Motion carried.

Thomas Theis made a motion second by Todd Bartlow to send Scott Sistek and Jeff McLaughlin to the PSAB Conference and Dean Clark as possible attendee. Motion carried with Thomas Smith voting no.

Thomas Theis made a motion second by Thomas Smith to advertise the Community Yard Sale. Motion carried.

Thomas Theis made a motion second by Linda Echard removing Melvin F. Steele, Jr. from the Vacancy Board. Motion carried.

Todd Bartlow made a motion second by Linda Echard appointing Melvin F. Steele, Jr. to the Zoning Hearing Board. Motion carried.

Linda Echard made a motion second by Todd Bartlow appointing Donna Bailey to the Vacancy Board. Motion carried.

Todd Bartlow made a motion second by Thomas Smith approving Theis subdivision plan. Motion carried with Thomas Theis abstaining.

Todd Bartlow made a motion second by Dean Clark requesting that the New Stanton Planning Commission and County Planning review and make recommendations on the following areas of the New Stanton zoning ordinance; consider raising the building height in B-1 business districts to 50' not including parapets; requiring fire lanes similar to those found in the Hempfield Township Zoning Ordinance; and review parking requirements; lowering hotel parking requirements from 1.5 to 1 per room; maintaining 1 space per employee on the largest shift, requiring 1 parking space per 65 square foot of conference room space, adopting shared parking similar to those found in the Hempfield Township Zoning Ordinance. Motion carried.

Council discussed the water issue in Chanticleer and that the cost would be approximately \$27,000.00 to fix the issue and that there was no money in the budget for the repair. Mr. Campfield suggested that a meeting take place between the property owners, the Borough and Mr. Pillsbury.

Todd Bartlow made a motion second by Brandon Clawson authorizing the Personnel Committee to hire a Summer Laborer for Public Works. Motion carried.

Council had some discussion on the Borough signs and that there needs to be a message on the signs at all times.

Todd Bartlow made a motion second by Brandon Clawson to purchase a welder/generator as described. Motion carried.
