January 6, 2014

Mayor Nicholas DeSantis welcomed everyone to the meeting and administered the Oath of Office to the newly elected council members.

Dean Clark nominated Scott Sistek for Council President there were no other nominations. The motion carried with Scott Sistek abstaining.

Thomas Smith nominated Linda Echard for Vice President of Council.

Scott Sistek nominated Wilbur Bussard for Vice President of Council.

The following is the vote for Linda Echard's nomination for Vice President.

Dean Clark, Scott Sistek, and Brandon Clawson voted no, with Thomas Smith voting yes and Linda Echard and Wilbur Bussard abstaining.

The following is the vote for Wilbur Bussard's nomination for Vice President.

Dean Clark and Scott Sistek voted yes with Thomas Smith and Brandon Clawson voting no. Since there was a tie vote, Mayor DeSantis broke the tie by voting yes. Linda Echard and Wilbur Bussard abstained.

Mayor DeSantis then turned the gavel over to Council President.

Council President called the January 6, 2014 Biennial Reorganization meeting to order at 7:10 p.m. The Invocation was given by Pastor Bane from the United Methodist Church and the Pledge of Allegiance was recited.

Members present were Linda Echard, Scott Sistek, Wilbur Bussard, Brandon Clawson, Dean Clark, and Thomas Smith. Also present Mayor Nicholas DeSantis, Code Enforcement Officer Melvin F. Steele, Jr., Solicitor John Campfield and Engineer Emil Bove.

Approval of Bills & Minutes

Thomas Smith made a motion second by Dean Clark to approve the minutes from the December 19, 2013 Council meeting. Motion carried.

Councilwoman Linda Echard read a letter to Council on her resignation of the two (2) year term on Council.

Thomas Smith made a motion second by Dean Clark accepting Linda Echard's resignation of the two (2) year term on Council. Motion carried.

Former Councilman Todd Bartlow addressed Council about the two year vacancy and that he would like to be considered for the position. The Borough Secretary stated that there is another application and gave it to Council President Sistek who then told everyone that the application was from Thomas Theis. Council briefly discussed the vacancy.

January 6, 2014

Thomas Smith made a motion second by Dean Clark to go out for proposals for Auditor. Motion carried.

Wilbur Bussard made a motion second by Dean Clark appointing Melvin F. Steele, Jr. as Chair of the Vacancy Board. Motion carried.

Wilbur Bussard made a motion second by Dean Clark appointing Emil Bove as Sewage Enforcement Officer with Michael Stack as the alternate for the Borough. Motion carried.

Thomas Smith made a motion second by Brandon Clawson approving Resolution 2014-770 appointing Hoffman Kennels as Animal Control Officer for the Borough. Motion carried.

There were no applications for the following vacancies of which there are two on Planning Commission, and one on Zoning Hearing Board and the UCC Appeals Board.

Brandon Clawson made a motion second by Linda Echard approving the following pay resolutions. Secretary Treasurer 2014-771, Assistant Secretary 2014-772, Borough Code Enforcement/Public Works Supervisor 2014-773, UCC Inspector 2014-774, 1st Class Laborer 2014-775, 2nd Class Laborer 2014-776, Part-Time Public Works 2014-777, and Part-Time Public Works - Seasonal (Park) 2014-778.
