Dean Clark made a motion second by Todd Bartlow to move the primary operating depository accounts to S & T Bank in accord with the proposal and create a sinking fund. Motion carried.

There was a brief discussion about a meeting that will be held at the Borough office with the CDBG on grant money.

There was a brief discussion about the Community Picnic that will be held August 2, 2014.

Council President read a letter from the Rollin Oldies after which there was a brief discussion.

Thomas Smith made a motion second by Todd Bartlow to allow the Rollin Oldies to use Pavilion B in September for their club picnic. Motion carried.
