## May 14, 2015

Councilman Dean Clark moved the office furniture to executive session and Council President added a lease agreement for the Brush truck that was purchased earlier this year.

## Code Enforcement

Melvin F. Steele, Jr.

Mr. Steele stated that we had seven (7) finished permits resulting in fees of \$1,134.10. Mr. Steele also updated Council on projects that are being done.

Todd Bartlow made a motion second by Dean Clark to sign the amendment to the Inter-Municipal Agreement with Hunker Borough. Motion carried.

Mr. Bove updated Council about the bid from Mele & Mele Inc. on the 2015 Street Improvement project.

Dean Clark made a motion second by Todd Bartlow to award the 2015 Street Improvement project to Mele & Mele Inc. for Bid A and Bid B in the amount of \$377,622.32 contingent upon Hunker Borough approving Bid B. Motion carried.

Linda Echard made a motion second by Dean Clark to purchase two (2) additional blinds for the Borough Office and Tax Collectors office in the amount of \$257.00 over the original amount approved. Motion carried.

Dean Clark made a motion second by Todd Bartlow to deduct \$3,000 from contract allowance for plants and shrubs. Motion carried.

Linda Echard made a motion second by Dean Clark to deduct \$849.33 from contract in supplying temporary heat for February, March and April. Motion carried.

Todd Bartlow made a motion second by Dean Clark to send Jeff to a Grant Writing Workshop June 18<sup>th</sup> for a fee of \$100.00. Motion carried.

Todd Bartlow made a motion second by Dean Clark to advertise the Community Yard Sale in the Tribune Review as well as putting the ad on Craig's list for a fee of \$25.00. Motion carried.

Dean Clark made a motion second by Todd Bartlow authorizing Mr. Campfield to withdraw action filed against Travelers Insurance concerning a bond for Centax. Motion carried.

Todd Bartlow made a motion second by Linda Echard to transfer \$197,413.95 from the LST Account to the General Fund to recoup money spent on the Fire Department from 2008 to April 2015. Motion carried.

Dean Clark made a motion second by Todd Bartlow to budget 20% of total LST funds to the Fire Department. Motion carried.

Linda Echard made a motion second by Dean Clark to accept Ralph Smith's resignation as Park Maintenance Person effective May 31, 2015. Motion carried.

Dean Clark made a motion second by Todd Bartlow to hire Denise Appleby as the Park Maintenance Person. Motion carried.

Todd Bartlow made a motion second by Dean Clark to sign a lease for the Brush Truck from the Borough to the Fire Department. Motion carried.
