Approval of Minutes of September 1, 2020

Todd made a motion seconded by Edwina to approve the September 1, 2020 meeting minutes Motion passed with Edwina, Linda and Todd voting yes and Scott and Josh abstaining.

Todd made motion seconded by Scott, to award the Shrader Hollow Culvert replacement contract to the apparent lowest responsible bidder, KGD Contracting, Inc. contingent upon review by Emil Bove and John Campfield of all bid documents and determining the responsibility of the bidder; if there is a problem, the award will be granted to the second low bidder Protocol, LLC. Motion passed unanimously.

Nancy Kukurin logged-off from the meeting.

2. M/V on Minimum Municipal Obligation for Borough Pension Plan

Todd made a motion seconded by Josh approving the 2020 Minimum Municipal Obligation for the borough pension plan. Motion passed unanimously.

3. M/V on to Renew Commercial Choice Real Estate Contract

Todd made a motion seconded by Scott to renew the contract with Commercial Choice Realty for another 6 months. Motion passed unanimously.

4. Update on Fire Truck Loan

Jeff stated that before taking out the fire truck loan, the borough has to receive permission from the state to raise the borough debt ceiling as per the Local Government Unit Debt Act. He stated that the Debt Statement (which outlines the amount of debt the borough has held over the last 3 years), the Borrowing Certificate and advertisement of the ordinance incurring the fire truck debt needs approved. He stated that that these forms along the proposals received from the 2 private lenders S&T Bank and First Commonwealth Bank were e-mailed to council for their review.

Jeff reviewed the two bank proposals. He stated that the First Commonwealth loan is lower at 2.9% than S&T's at 3.07%, but First Commonwealth only guaranteed the rate for 60 days from September 1, 2020 (The borough asked that lenders provide a 90-day guarantee which S&T provided). Jeff stated that he was concerned that the borough would not be able to close within 60 days given the need to adopt the ordinance and receive approval from the state. First Commonwealth's reset ceiling is 3.40% and S&T's reset ceiling is 7%. First Commonwealth also added a fee of \$1,000. The only fee which S&T is charging is for documents.

The monthly principle and interest for S&T would be \$2,884.87 and \$2,857.76 for First Commonwealth, including adding the \$1,000 fee to the principle. This is a difference of \$27.11 a month.

Scott made a motion seconded by Todd to approve the debt statement, borrowing certificate, the letter to DCED and all other LGUDA documents, as well as to advertise the debt ordinance to be considered at the October 6, 2020 meeting contingent upon review by John Campfield. Motion passed unanimously.

Todd made a motion seconded by Scott to authorize three council members to sign off on the debt statement, borrowing certificate all of the other necessary LGUDA documents needed for the purchase of the fire truck. Motion passed unanimously.

5. M/V to Purchase 2 Lawn Tractors

Jeff reviewed the three quotes that were solicited and received:

Todd made a motion seconded by Edwina to purchase two John Deere lawn tractors from the low bidder Middletown Tractor in the amount of \$11,872.48. Motion passed unanimously.

6. Discussion Regarding Halloween/Trick-or-Treat

It was decided not to hold the parade this year because of COVID-19, but to still allow for Trick-or-Treat for those residents that want to participate.

Scott made a motion seconded by Todd to hold Trick-or-Treat on Halloween, October 31st from 5 PM until 7 PM. Motion passed unanimously.

7. M/V on Proclamation Regarding May Ronald Echard, Resolution 2020-950 Jeff read the resolution:

BE IT FURTHER RESOLVED, and it is hereby further resolved that this Resolution be spread upon the minutes of this meeting as a monument to **RONALD L. ECHARD**; and further that a copy of this Resolution be forwarded to his wife, Linda; and his daughter, Elizabeth, with our sympathy and blessing.

8. Resignation of Scott Sistek from Council

Jeff stated that the borough received a letter from Scott Sistek stating that he is resigning from council.

Todd made a motion seconded by Josh accepting Scott Sistek's letter which states that he is resigning from council. Motion passed with all voting in favor with the exception of Scott who abstained.

Note: Scott did not vote on the remaining motions, because he was no longer on council.

9. Filling Office of Mayor

Todd made a motion seconded by Josh adopting Resolution 2020-951 appointing Scott Sistek to the office of Mayor until the first Monday in January 2022. Motion passed unanimously.

Todd stated that with the last opening on borough council, several people came forward. He mentioned that Alex Brown was one of those that expressed interest. Alex Brown stated that he is still interested.

Todd made a motion seconded by Edwina to adopt Resolution 2020-952 appointing Alex Brown to council until the first Monday in January 2022 contingent upon the receipt of all necessary paperwork. Motion passed unanimously.
